

# Guernsey Finance Code of Conduct – attendance at events

Guernsey Finance is committed to bringing members together in a professional environment to collaborate and network. It is important to Guernsey Finance that everyone attending our conferences and events has a positive and rewarding experience. We invite all sponsors, volunteers, speakers, attendees, and others ("participants") to create a safe, respectful, and positive experience for everyone.

Guernsey Finance has established this Code of Conduct as a framework and a guide to expectations, providing guidelines to participants and ensuring that all participants understand what behaviour is expected and what behaviour will not be tolerated at a Guernsey Finance event. It is important to be mindful that this Code of Conduct should not be interpreted too literally but rather as a guide to foster a positive environment. Guernsey Finance expects all participants to abide by this Code of Conduct at all events. This includes conference-related social events at off-site locations and in related online communities and social media.

Guernsey Finance will take all reasonable steps to provide a harassment-free and inclusive event experience for everyone, regardless of gender identity and expression, sexual orientation, disabilities, neurodiversity, physical appearance, body size, ethnicity, nationality, race, age, religion, or any other protected category. Participants asked to stop any harassing behaviour are expected to comply immediately.

### **Expected behaviour**

Guernsey Finance expects that participants will:

- 1. Be considerate and respectful to all participants.
- 2. Refrain from demeaning, discriminatory, or harassing behaviour, materials, and speech.
- 3. Speak up if they observe anything at an event that conflicts with this Code of Conduct. If you are being harassed or feel uncomfortable, notice that someone else is being harassed, or have any other concerns, please contact a member of the Guernsey Finance event staff immediately.

#### Unacceptable behaviour

Unacceptable behaviour from any participant will not be tolerated. Unacceptable behaviour includes, but is not limited to:

- 1. Intimidating, harassing, abusive, discriminatory, derogatory, or demeaning speech, materials, or conduct by any participants of the event and related event activities.
- 2. Violence, threats of violence, or violent language directed against another person.
- 3. Sexist, racist, homophobic, transphobic, or otherwise discriminatory jokes and language.
- 4. Personal insults, particularly those related to gender, sexual orientation, race, religion, or disability.
- 5. Inappropriate photography or recording.
- 6. Taking of photos within the event environment for use on social media, without the prior permission of the individuals or owners of the content therein.
- 7. Any boisterous, lewd, or offensive behaviour or language, including but not limited to using sexually explicit or offensive language, materials or conduct, or any language, behaviour, or content that contains profanity, obscene gestures, or racial, religious, or ethnic slurs.
- 8. Failure to obey any rules or regulations of the event venue.

#### Consequences of unacceptable behaviour

Unacceptable behaviour will not be tolerated. Anyone asked to stop unacceptable behaviour is expected to comply immediately. If a participant engages in unacceptable behaviour, Guernsey Finance may take any action it deems appropriate, including warning or expelling the offender from the event with no refund. For more serious displays of unacceptable behaviour, Guernsey Finance may, in its reasonable discretion, temporarily ban or permanently expel a participant from future Guernsey Finance events.



## What to do if you witness or are subjected to unacceptable behaviour

If you are subjected to unacceptable or unwelcome behaviour, notice that someone else is being subjected to unacceptable or unwelcome behaviour, or have any other concerns, please notify Guernsey Finance events team as soon as possible. Guernsey Finance event staff will be available to assist those experiencing unacceptable behaviour to feel safe for the duration of the event. All reports will remain completely confidential.

This Code of Conduct is the product of Guernsey Finance's commitment to support a welcoming, respectful, and collaborative community, and we thank our participants for sharing our commitment.
